While on the subject, time is a wastin' for signing up for the TSRA Regional Match on August 30. Texas Ghost is spreading the word at other clubs in the region but if you haven't registered yet I encourage you to do so. You can download the registration form from our website and it is also included in this newsletter. Mail it directly to Texas Ghost (a.k.a. Tray Golden). You have to be a member-in-good-standing of TSRA and you should be anyway if you enjoy this game as much as I do. Proceeds from the match will go toward supporting the TSRA in their continuing protection of our Second Amendment rights. Come out and enjoy this match and show your support of the TSRA to boot!

Wild Bunch has been of some interest lately. We had a Wild Bunch Match on May 31st that generated a lot of email discussion. I think there was a final consensus to put some limits to the number of stages, number of magazines and number of shots fired on the matches. So I guess there really is such a thing as "too much of a good thing." At the June Cowboy Action Shooting (CASTM) match on Saturday we had additional scenarios written for Wild Bunch to support a separate Wild Bunch posse. Despite the fact that not enough Wild Bunch shooters materialized for that dedicated posse we were able to integrate those few who did into the other posses and have them shoot the same scenarios using 2 magazines instead of 2 handguns. They were also allowed to engage rifle targets with the 1911 instead of using the rifle. We did the same on Sunday and that practice will be continued at all future regular monthly matches with separate scenarios for a Wild Bunch posse provided at the Saturday match only. But even for dedicated Wild Bunch matches such as the one scheduled for August 31th we will establish a limit of five stages and four magazines. I have also suggested a limit to the number of "shots" but that is still being discussed. And as we decided for the last Wild Bunch match on May 31st, if anyone wants to come out and shoot cowboy at the Wild Bunch match they are more than welcome. Turnabout is fair play we used to say.

Thanks again to **Quintana** for running another Long Range side match all in the spirit of the Battle of Walkers Creek. It was a definite challenge to try to shoot out to 75 yards with the handgun! But I will let him tell you more in his message. **Quintana** and his band of "buffalo hunters" have now extended the roof lines at the Long Range stage to provide more shade. And in the future that amount over coverage is planned to double again. In July we will hold the Long Range on Saturday afternoon and on Sunday morning we will have a much requested "sighting in" day.

Shooting Iron Miller

COMMODORE PERRY OWENS



Owens was a lawman and gunfighter of the Old West. His father, Oliver H. Perry Owens was named in honor of Commodore Perry. When Commodore Perry Owens was born on July 29, 1852 it was his mother that selected the name "Commodore Perry Owens". Owens spent his early life in Tennessee and Indiana but by his early teens had left home to work as a cowboy on ranches in Oklahoma and New Mexico. Although not much is known about his early years, Owens admitted to running with a "gang of tough characters" and probably was involved in rustling, whiskey running and other "depredations in the Indian Territory".

Owens homesteaded outside of Navajo Springs, Arizona and named his place the "Z-Bar Ranch" although he never officially registered the brand. In 1886, Owens was elected Sheriff of Apache County, Arizona, approximately 20,000 square miles of territory. Apparently Owens was well liked within his jurisdiction and well-fitted for the job being trained in the use of both the six-gun and rifle. When he took office on January 1, 1887 he was given several bench warrants that his predecessor Jon "Don" Lorenzo Hubbell had not served. Included among the warrants were Mormon gunman Lot Smith, former Tombstone outlaw Ike Clanton, and rustler Andrew Arnold Cooper, aka Andy Blevins.

Cooper was a native of Texas but left the state and moved to Arizona in 1885 with his brother Charlie Blevins to escape arrest for crimes he had committed in Texas. While in Arizona, the Cooper brothers aligned themselves with a family by the name of Graham. The Graham family was involved in a range war with the Tewksbury brothers, a range war that became known as the Pleasant Valley War. The Graham family was known as cattlemen in the area while the Tewksbury brothers, although originally cattle ranchers, had herds of sheep.

On September 4, 1887 Sheriff Owens traveled to Holbrook in the Arizona Territory and attempted to serve the warrant he held for Andy Cooper Blevins. When Owens arrived there were at least ten people in the house. As the story goes: "cradling a Winchester in his arm, Sheriff Owens knocked on the door and Andy Blevins answered the door with a pistol in his hand". When Andy Blevins refused to comply with the Sheriff's request and tried to close the door, Sheriff Owens shot Cooper through the door. Sheriff Owens would fire several more times wounding John Blevins in the arm, shooting Mose Roberts in his back, as he tried to escape, and fifteen year old Samuel Houston Blevins, brother of Andy Blevins. Reports say the entire incident took less than one minute but it was a shoot-out that would make Sheriff Owens a legend. [The TV movie *To the Last Man* starring James Arness was based on the Pleasant Valley War and the Owens famous shoot out

Although Owens was denied a second term as Sheriff in November 1888, the legendary sheriff represented law and order at a time when it was most needed.

In August 1893 he was appointed to the position of Deputy U.S. Marshall under William Kidder-Meade. In 1895 Apache County was split into two counties, the eastern part remained Apache County and the western part became Navajo County. Owens was appointed by Governor Hughes as the first Sheriff of the newly created Navajo County and served in that capacity for two years. Tiring of the law business, Owens retired to Seligman, Arizona where he lived and ran a general store and saloon.

In 1912, Owens saw the Arizona Territory, which he had helped to settle, become the 48th state in the Union. Owens died on May 28, 1919 at the age of 67. He is buried in Flagstaff, Arizona.

Participating Texican Rangers each made use of one pistol for Long Range shooting in addition to their Big Bore or Pistol Caliber rifles. Sunny and breezy weather contributed to the making of a great day to sniff the aroma of gun powder in the shade of the long range stage. A big thanks to L.W. Hannabass, Wild Cat Bob, John Wren, Chasen Aces and Tricky Tunes for spotting downrange.

June Match Results

Texican Rangers began their shooting sequence with five rounds fired from one pistol followed by their rifle. Shooters “surprised” the steel feathered targets by engaging one pistol round at 25 yards followed by two rounds each at 50 yards and 75 yards. Then Rangers engaged the rifle targets. All competitors shot the match with rifles supported from a bench rest table and all shooters fired smokeless rounds, unless noted otherwise. Big Bore shooters engaged targets ranging 100 to 200 yards for a total of 8 rounds. Pistol Caliber Rifle shooters engaged targets from 50 to 200 yards with 11 rounds.

Five revolver shots at a combination of 25, 50 and 75 yards in addition to your choice of Long Range Rifle. Ammo Count: 5 rounds pistol and 8 rounds big bore rifle or 11 rounds pistol caliber rifle.

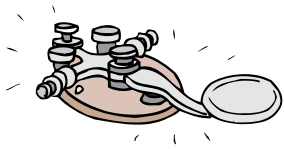
Sunday-July 13: Practice Session (will run during our monthly Sunday CAS match)

Ample time will be available for practice and match activities. For **PRACTICE SIGHTING IN** we will have THREE plywood targets **FOUR FEET by FOUR FEET** with a large 15 inch black bull with a 6 inch white center bull placed at 100, 150 & 200 yards. This will be a great opportunity to fine tune one's familiarity with the intricacies of the sighting apparatus so sturdily mounted upon their long-range armament and get feed-back from spotters to zero in the sight settings fundamentally improving your shooting experience. The targets are large but some of us may still miss the barn door. *So bring a lot of lead!* Big Bore shooters will have priority over pistol caliber participants but there should be ample time for all. **VOLUNTEER SPOTTERS** will be needed to use the two to three spotting scopes. Because we will NOT be able to go down range to service the 4X4 plywood targets during the CAS match, the spotting process with scopes will require careful attention as target faces become riddled and will lack the resounding clang of steel. Upon the completion of the CAS match, Long Range will also conclude, unless otherwise authorized.

TEXAS HISTORY-JUNE

- 1851-June 24th A new fort, Fort Belknap, anchors the Texas line of defense. Fort Belknap was a four-company post. Companies from the Fifth and Seventh U.S. Infantry, Second U.S. Dragoons, and Second and Sixth U.S. Cavalry served there at various times. Belknap was the northern anchor of the chain of forts protecting the Texas frontier from the Red River to the Rio Grande
- 1832-June 26th The Mexican fort at Velasco surrendered to Texas colonists in the battle of Velasco, probably the first occasion of bloodshed in relations between Texas and Mexico. Between 100 and 150 Texans, under the command of Henry Smith and John Austin, had gone to Brazoria to secure a cannon for use against Mexican forces at Anahuac
- 1874-June 27th A party of about 700 Plains Indians, mostly Cheyenne, Comanches, and Kiowas, attacked a buffalo hunters' camp about a mile from the ruins known as Adobe Walls (the scene of a previous encounter between Indians and U.S. troops), in what is now Hutchinson County. The battle and the siege that followed became known as the Second Battle of Adobe Walls. William (Billy) Dixon is reported to have shot an Indian off his horse from a distance of seventh-eighths of a mile. The larger significance of this fight is that it led to the Red River War of 1874-75,
- 1880-June 28th John Burwell Omohundro Jr., better known as Texas Jack, died. He served as a scout and spy under Gen. J. E. B. Stuart during the Civil War. By 1866 he had resumed his life as a Texas cowboy and rode in several early cattle drives, including a drive across Arkansas to Tennessee, where he received his nickname "Texas Jack."

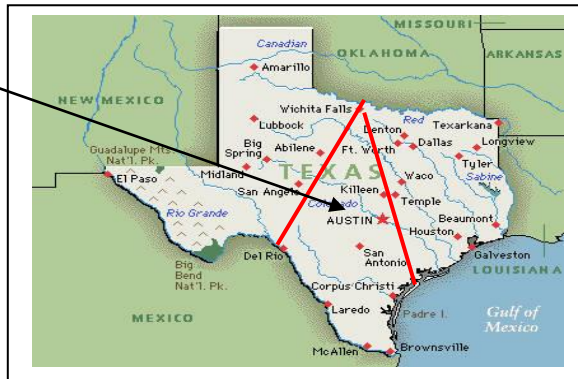

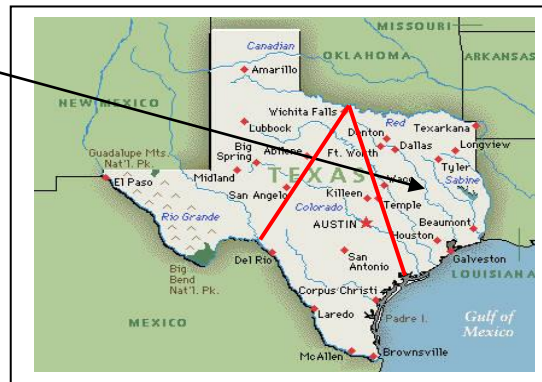

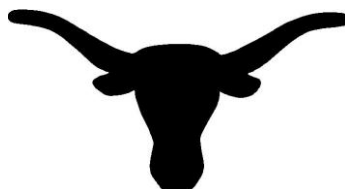
